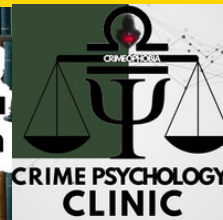
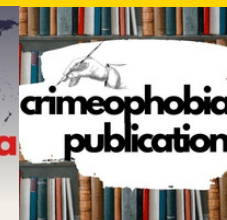
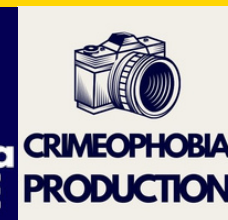
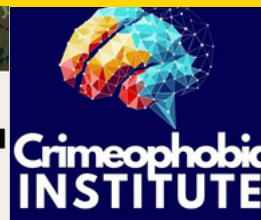
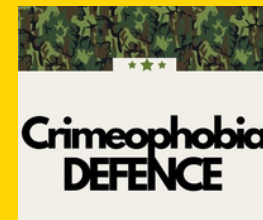
## Films, TV Serials, OTT and YouTube Channel

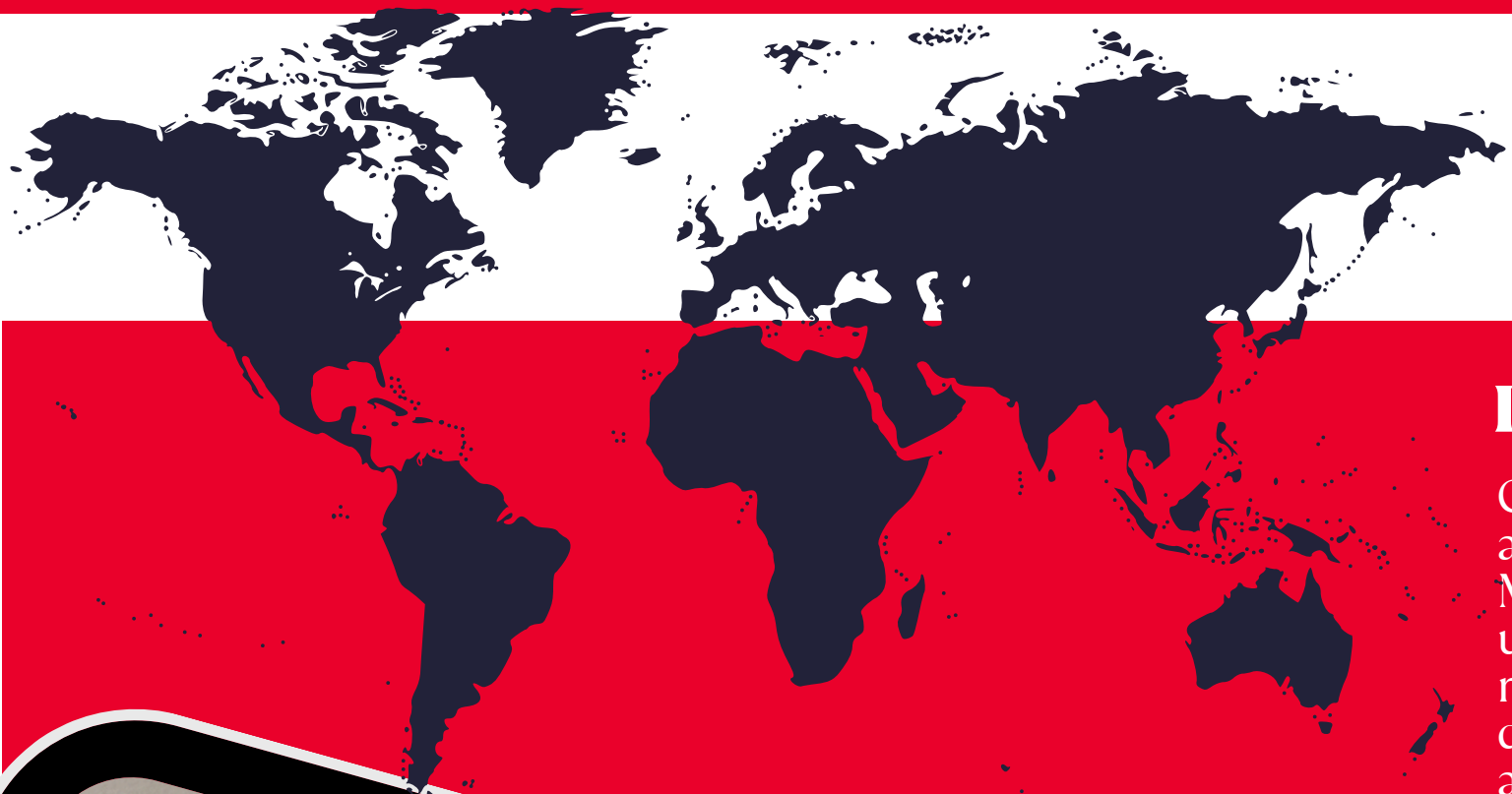

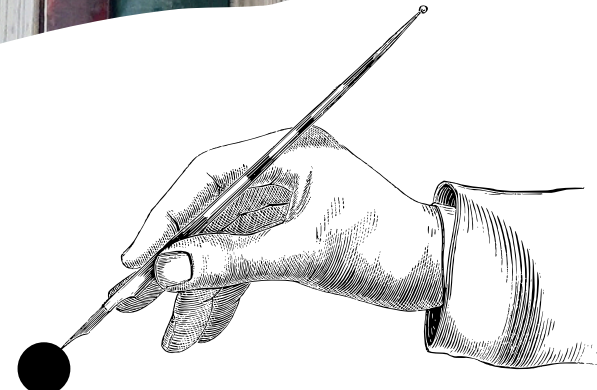


